Terms and Conditions of Sale

1. Customs Status

The vehicles have not been customs-cleared.

2. Condition of Sale

The vehicles are sold by the Embassy of Italy in Baghdad on an “**as is**” basis, without any warranty, express or implied, as to its condition or performance.

3. Customs and Registration Costs

All costs related to customs clearance (if required) and vehicles registration shall be borne solely by the buyers.

4. Payment

Payment shall be made in United States Dollars (USD) by bank deposit.

5. No Returns

Sales are final; no returns or refunds will be accepted.

6. Removal of Vehicle

The buyer shall remove the purchased vehicle from the Embassy’s premises within three (3) calendar days following receipt of payment.

7. Submission of Offers

Prospective buyers are required to submit their offers to Embassy of Italy, Villa W9 -Dijlah Diplomatic Compound International Zone, Baghdad, during working time by **4:00 pm, 4 October, 2026.**

8. Offers

Offers must be submitted in a sealed envelope containing the following:

- Indication of the vehicle for which the bid is being made (No. 1 / No. 2 / No. 3)
- The offered price
- The date of submission
- The bidder’s contact information (name and telephone number)
- The bidder’s signature

Bidders intending to submit offers for more than one vehicle must prepare a sealed envelope for each vehicle.

9. Late or Improperly Submitted Bids

Late bids or bids submitted in unsealed envelopes will not be considered. Envelopes must be clearly marked with the following note:

“BID FOR THE SALE OF SERVICE VEHICLE – DO NOT OPEN.”

10. Bid Opening

Bids will be opened in a public session at the Chancery of the Embassy of Italy on October 5, 2026, at 11:00 AM.
